## 2019 RAFFLE OFFICIAL RULES

Foundation for a College Education (FCE), a California public benefit corporation described in Section 501(c) (3) of the Internal Revenue Code, is conducting this raffle pursuant to California Penal Code Section 320.5 for ongoing charitable purposes. The rules and regulations are set forth below.

### 1. ELIGIBILITY

By entering Foundation for a College Education's **March to Success** Raffle, each entrant agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations. Entrant further agrees to release FCE and its directors, officers, agents and employees from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. Entrant further agrees to be bound by FCE decisions and interpretation of these rules.

The Raffle is open to any eligible person residing in any place where the Raffle is not prohibited by state, local or other laws. Entrants must be an individual 18 years or older at time of entry purchase. Only one (1) individual may be identified as the purchaser (or buyer) of the raffle entry.

Entrants need not be present to win.

### 2. CERTIFICATE PURCHASE

The cost to purchase a single entry ("Certificate") for the Raffle is US\$20.00. Three (3) Certificates may be purchased for US\$50.00. Seven (7) Certificates may be purchased for US\$100.00. The purchase of Certificates is not tax deductible. There is no limit on the number of Certificates any entrant may purchase. A Raffle Ticket Order Form may be downloaded via the internet at [www.collegefoundation.org](http://www.collegefoundation.org) or by calling 1-650-322-5048 between 10:00 a.m. and 5:00 p.m. PST Monday through Friday. Due to California State Law, the purchase or payment of a Ticket may not be made via the internet.

Certificate payment can be made by cash, check, or money order. FCE and its staff, agents, Board, vendors, volunteers, and members assume no liability for lost, late, misdirected, mutilated, incomplete, illegible, undelivered entries or entries without proper payment received, which entries shall be deemed invalid and shall be immediately disqualified.

If an entrant's payment is dishonored by a bank for any reason, such entrant's Certificate will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Completed Raffle Ticket Order Form and payment must be received either at the FCE office (2160 Euclid Ave, East Palo Alto) by 5:00 p.m. PST on Wednesday, April 10, 2019, or at Garden Court Hotel, 520 Cowper Street, Palo Alto) by 7:00p.m. Saturday, April 13, 2019, to be eligible for the Prize drawing.

All Raffle Ticket Order Forms will be handled and recorded on a first come, first served basis. Any certificate forms and payments (including payments previously dishonored) received after closure of the Raffle will be returned to the entrant. Upon receipt of a completed registration form and valid payment, a Certificate with assigned drawing number will be issued. The Certificate shall be mailed to the entrant within ten (10) business days of issuance. All purchases of Raffle Certificates are non-refundable after an entry has been included in any prize draw, unless the Raffle has been cancelled under the terms listed in Section 4 below.

No more than one person may purchase the Certificate. The Certificate stub is not transferrable or assignable. Entrants may not sell, donate or otherwise transfer their Certificate(s) to anyone. Prizes will not be issued to anyone other than the entrant(s) whose name is on the Certificate stub.

An unlimited number of Certificates will be sold. The chances of winning are based on the number of Certificates sold.

Each numbered Raffle Certificate stub will be placed in the Raffle Certificate container.

FCE will be responsible for maintaining control and security of all the Raffle Certificate stubs.

### **3. PRIZES**

The Raffle drawing will be held on April 13, 2019 at Garden Court Hotel (520 Cowper St, Palo Alto, CA).

If the Raffle is not modified or canceled under the terms of Section 4 of the rules, FCE will award three prizes to the lucky winners. Prizes are provided in "as is" condition with no guarantee or warranties from FCE.

Winners will be determined by random drawings of all the eligible Certificates received by the entry deadlines. If an entrant's Certificate is chosen as a prize winner, that certificate becomes ineligible for remaining prize drawings.

In the event that a winning Certificate has more than one (1) name listed, FCE will award the prize to the first name listed on the entry. The records of FCE shall be deemed correct if there is a discrepancy or dispute. FCE is not responsible for resolving any disputes that may arise from different individuals listed on a valid Certificate. Any and all prizes inure only to the designated winner and may not be transferred, sold or otherwise made available to another party.

Winners need not be present to win. Drawings are not open to the public.

### **4. MODIFICATION OR CANCELLATION OF DRAWING**

FCE reserves the sole right to cancel or modify the Raffle. If less than 200 Certificates are sold by 7:00p.m., Saturday, April 13, 2019, FCE, at its sole option, may modify the Raffle by withdrawing Prize Two (\$500 Apple Gift Certificate). If less than 125 Certificates are sold by 7:00p.m., Saturday, April 13, 2019, FCE, at its sole option, may cancel the Raffle drawing. In the event that the Raffle is cancelled because of insufficient Certificate sales, FCE reserves the right to refund all monies, minus a \$1.00 processing fee.

### **5. WINNERS**

More than one name may be listed on a registration form, but the first name listed shall be deemed to be the winning entrant. A social security number must be provided, and it must be that of the entrant. Delivery or payment of any prize shall be made solely to the entrant. It is the sole responsibility of the entrant in a multiple party entry to allocate any such prize among the participants in a multiple party entry. Winners will be notified by phone, e-mail or by mail based on the information received on the Raffle Ticket Order Form.

Winners' names, city and state will be available to all media and will be available at the offices of FCE and listed on FCE's Website. For a list of winners, send a self-addressed, stamped envelope to Winners List, FCE Raffle 2019, 2160 Euclid Ave, East Palo Alto, CA 94303. Winning entrants agree to allow FCE to use their names, likeness, and any statements made by them regarding the prize for advertising or publicity purposes without compensation.

Winners may be required to complete and return an affidavit of eligibility and/or liability release and required tax forms. A winner's failure to do so if requested or if one otherwise fails to comply by these rules and/or to make arrangements to claim his or her prize within ninety (90) days of a drawing notification will void that entry. If a winner cannot be contacted or located by reasonable means by June 15, 2019, the prize will be deemed forfeit and shall be considered to have been donated to FCE for its charitable purposes.

Except where prohibited by law, the winner of the Raffle and acceptance of the Prize constitutes permission for FCE to use said winner's name, photograph, likeness, statements, and biographical information for promotional or advertising purposes in connection with this raffle on a worldwide basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation. Winner must claim prize with FCE, and sign and deliver a completed W-9 Form at the time of settlement, should FCE require. FCE reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered entry form and entries that do not include valid or complete payment. FCE is not responsible for printing errors in any drawing-related material, or for lost, late or mis-directed mail, or any other failure to receive orders or delivery receipts prior to the drawing deadline. Any individual 18 years of age or older at the time a Certificate is purchased may purchase a Certificate, except as provided by law. A Raffle Certificate may be registered in the name of an individual who is a United States citizen or United States resident for US federal tax purposes.

All purchases of Raffle tickets are NOT tax-deductible. All cash prizes will be paid net of applicable income tax withholding. All winners shall be responsible for federal, state and local income or excise taxes, fees, assessments and like charges associated with the prizes.

## **9. AUTHORITY AND CONTROL**

The decision of FCE shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of California. The Raffle is void where prohibited by law. FCE is not responsible for any errors or omissions in the Raffle's advertising and/or any printed, broadcast, or Internet-provided materials or information. ## **10. STATE OF CALIFORNIA NONPROFIT RAFFLE REGISTRATION**

By letter from the California Attorney General's office, FCE has registered with the California Department of Justice under Raffle Registration Number RF0002213 and is authorized to conduct raffles in California, pursuant to the provisions of Penal Code section 320.5.
